Our Sustainability Levy

Through our sustainability levy, Dulini helps to fund the ongoing conservation of a vast tract of pristine bushveld, as well as several impactful upliftment projects in the communities surrounding the Sabi Sand Nature Reserve.

The levy serves as a means to foster deeper comprehension and consciousness among our guests of the favourable effects of their visit.

The levy includes:

*All levies are applicable per person per night. Adults are from 17 years and older; Children are aged 16 years and younger. We have faith in the potential of responsible tourism to generate substantial positive transformations, and through the implementation of this levy, we are committed to leaving a lasting and valuable impact on this invaluable ecosystem.

The esiDulini Trust

The esiDulini Community Trust is a registered non-profit organisation reaching out to the communities surrounding the Sabi Sand Nature Reserve. We believe we have a responsibility to extend our hand to our neighbours who live rural lifestyles far from the reach of government spending and service provision.

Land Management Levy

As custodians of over 1860Ha of land within the SSNR Dulini takes responsibility for various conservation efforts. These include fire management, water management, protection of large red-listed trees, erosion site rehabilitation and management, control of alien plant species, and active involvement in Greater Kruger research projects, such as Ground Hornbill research, Vulture research, Elephant research, and Leopard research. The land management fee contributes to the costs associated with these conservation interventions on the land under our direct management.

Sabi Sand Nature Reserve (GCC)

Our GCC Levy plays a pivotal role in the security and protection of wildlife, as well as in facilitating ecological management within the Greater Kruger Area.

supporting various

including research projects
within the Greater Kruger
Region. This fee is directed to
the Sabi Sand Nature Reserve
and is crucial for the operational
functioning of
the reserve. It aids in funding
essential activities such as
fenceline maintenance, antipoaching efforts, and overall
security measures.

Bushbuckridge Community Levy

Bushbuckridge is a local community bordering the reserves of the Greater Kruger. The region faces challenges in raising funds for municipal operations, given its sparse population and lack of affluent households. We are committed to providing monthly statutory levies to assist the municipal authorities in funding their operations. The Bushbuckridge Local Community levy helps support this cause, directly benefiting the local communities through their municipal structures.
